**Facilities:** UMLY has a 6 lane heated 25 yard pool with Kiefer non-turbulent lane lines, a 10 foot starting end. There is seating capacity for 200 and large on-site parking. An adjacent full gymnasium will be utilized as a ready room for swimmers.

**Eligibility:** This meet is open to any swimmer who is 8 years old or younger as of **December 1, 2007**. This will be strictly enforced.

**Entries:** The swimmer may enter a maximum of three individual events plus one medley relay and one free relay. All entries for individual events and relays must be listed on the official entry forms (forms attached), or submitted on 3.5" disk using **Hytek Team Manager** (see attached description). **Entries must be in YARD TIMES.** Relays should be entered as A, B, etc only. Relay cards will be handed out at the coaches meeting to be filled out with the swimmers' names.

**Entry Deadline: 6:00PM Friday, February 15, 2008.**

Entry data may be e-mailed. Entries (data, MM paperwork, entry fees) must be mailed so as to be **RECEIVED** by entry deadline. Do not mail entries with "Signature Required." Entries received will be accepted on a first come, first served basis, so please send in your entries early. **Meet will be limited to 250 athletes per session.** The Meet Director has the right to refuse entries prior to the deadline date if the meet becomes over subscribed.

**Entry Fees:** \$3.50 per individual event and \$12.00 per relay team. **Please send ONE CHECK ONLY** for the total amount of your team entries: we will not accept a collection of individual checks from your team members. Your check should be made payable to UMLY SWIM TEAM PARENT'S ASSOCIATION.

**Rules:** This meet will be governed by the current NCAA Swimming Guide. All events are timed finals. One false start will be allowed. **Coaches should attend the coaches meeting.** Relay Cards will be handed out prior to the meet.

**Timers:** Each team **must** supply one timer for each session. If your team has more than 10 swimmers participating in a session, two (2) timers are required. **Coaches will be held responsible for providing timers on the day of the meet.** Thank you for your help!!

**Awards:** For individual events: Medals (1st-3rd), Rosettes (4th-8th), and Ribbons (9th-12th). For relay events: Medals (1st -3rd), Rosettes (4th -6th), and Ribbons (7th -12th). High Point: First, Second, and Third place "High Point" team trophies for girls' teams and boys' teams. Other: Heat winner ribbons, participant patches, and ribbons for event record breakers. Awards will be given to the respective coaches at the conclusion of the meet. Awards will not be mailed.

**Admission:** All day admission to the meet for friends and family members is \$5.00 per adult and free for children. Admission to one session is \$3.00. Programs cost \$2.00 for each session.

**Notes:** Notification of any changes to the meet will be made to contact person from each team. Please list the contact person, address, telephone number and E-Mail address on the Meet Entry Summary form.

**Inclement Weather:** There is no snow-date. Call the YMCA @ 610-647-9622 if you have questions regarding cancellation.

**Concessions:** Custom t-shirts, refreshments, and swimming accessories by TOAD HOLLOW of Berwyn will be available. Concession area will be located in Gymnasium.

**Address:** Upper Main Line YMCA, 1416 Berwyn-Paoli Road, Berwyn, PA 19312 (610) 647-9622

**From Delaware:** Route 202 North to Swedesford Road/Chesterbrook Exit. Turn right. Go to the first light. Turn right onto Route 252. At the second light cross over Route 30. At the second light beyond Route 30, turn left onto Sugartown Road. Within 1/4 mile as Sugartown veers right, turn left onto Berwyn-Paoli Road. UMLY is on Berwyn-Paoli Road on the right.

**From Philadelphia:** Take the Schuylkill Expressway (Interstate 76 West) to Route 202 South exit. Take 202 South to Paoli Exit (Route 252 South). Stay on Route 252 and cross Route 30. At the second traffic light, turn left onto Sugartown Road. Within 1/4 mile as Sugartown veers right, turn left onto Berwyn-Paoli Road. UMLY is on Berwyn-Paoli Road on the right.

**From the PA Turnpike (Interstate 276/76):** Take Exit 24 (Valley Forge Exit.) This becomes the Schuylkill Expressway (Interstate 76). Take the Route 202 South Exit. Follow Route 202 to the Paoli Exit (252 South.) Stay on Route 252 to Route 30. Cross Route 30. At the second light beyond Route 30, turn left onto Sugartown Road. Within 1/4 mile as Sugartown veers right, turn left onto Berwyn-Paoli Road. UMLY is on Berwyn-Paoli Road on the right.
